RESERVED PICNIC AREA REGISTRATION FORM

Permit Includes:

1. A sign with the name of your group or event posted above your picnic area. (If you have rented half the area, please check the sign to be sure you are in the correct side)
2. Empty trash cans and picnic tables. (Except in unimproved areas)
3. Picnic area cleared of debris.
4. The picnic area you have reserved will be available to your group exclusively during the time stated on your contract. If someone else is using your area and will not leave, please telephone park staff by cell phone at **(916) 225-5149**.

Picnic Rental Rules: *(initial after each item below)*

1. Decorations may be attached to structure or tables with the following ONLY: **blue painter's tape, removeable mounting putty, string or zip ties** and must be removed at end of event. _____*(initial)*
2. All vehicles must park in designated parking areas. **Vehicles may NOT drive in park or on park pathways.** _____*(initial)*
3. Consumption of alcoholic beverages is prohibited in Fulton-El Camino Recreation and Park District parks except by permit only and only in designated picnic rental areas. **(No alcohol permitted in Seely Park)** _____*(initial)*
4. Park Police are charged with maintaining order in our parks. Should they feel that a situation is not in the best interest of other park users, they may require that your group surrender all alcoholic beverages or leave the park. _____*(initial)*
5. Glass containers are prohibited to ensure patron safety. _____*(initial)*
6. **Music** is allowed, provided that, it cannot be heard 100 feet away from the source. _____*(initial)*
7. **Charcoal is permitted in District provided barbeques. Personal propane barbeques and personal charcoal barbeques are not permitted in any park.** _____*(initial)*
8. Your group is required to clean up the area after your event. _____*(initial)*
9. You are required to vacate the area at the time indicated on your permit. (Hourly rental fees will be deducted from Deposit for any overtime usage.) _____*(initial)*
10. Check-in/check-out sheet must be signed off by Park official to determine refund of **\$75 deposit.** _____*(initial)*
11. **Cancellations-** A refund is given if reservation is cancelled at least 1 week prior to your reserved date, you will be charged a \$20 processing fee. _____*(initial)*

INDEMNIFICATION AGREEMENT
