

RESOLUTION NO. 15302

IN THE MATTER OF THE FORMATION OF THE
FULTON-EL CAMINO PARK, RECREATION AND
PARKWAY DISTRICT

WHEREAS, on the 2nd day of November, 1955, there was filed in the office of the Clerk of the Board of Supervisors of Sacramento County, California, a petition describing certain territory therein, genuine and sufficient in law, requesting the formation of a park, recreation and parkway district to be known as "FULTON-EL CAMINO PARK, RECREATION AND PARKWAY DISTRICT", and

WHEREAS, under and by virtue of Resolution No. 15,210, duly adopted and passed by this Board of Supervisors on the 16th day of November, 1955, Monday, the 12th day of December, 1955, at the hour of 10:00 o'clock a.m. of said day, and the Board Room of the Board of Supervisors of Sacramento County in the Sacramento County Court House in the City of Sacramento, County of Sacramento, State of California, were duly fixed as the time and place for the hearing of said petition, and

WHEREAS, on said 12th day of December, 1955, said matter was duly and partially heard and thereupon continued until the 19th day of December, 1955, at the hour of 10:00 o'clock a.m. of said day, and

WHEREAS, notice of said hearing has been given in the manner and form and for the time required by law, and

WHEREAS, no protests have been filed in said matter with this Board of Supervisors, or at all, and

WHEREAS, it appears to this Board of Supervisors, and this Board of Supervisors so finds that said boundaries described in said Petition, should be fixed and established, and

WHEREAS, it appears to this Board of Supervisors, and this Board of Supervisors so finds that said project is feasible, economically sound and for the public interest.

NOW, THEREFORE, BE IT RESOLVED that the name of said district shall be, and is hereby designated "FULTON-EL CAMINO PARK, RECREATION AND PARKWAY DISTRICT" which is the name proposed in the Petition hereinabove referred to.

BE IT FURTHER RESOLVED that the boundaries of said district, all of which are in said Sacramento County, shall be, and are hereby fixed, determined, described and established as follows, to-wit:

All that certain territory situate, lying and being in the County of Sacramento, State of California, described as follows:

Beginning at the point of intersection of the center lines of Watt Avenue and Arden Way, being the south east corner of Section 29, as shown on the "Map of Survey and Subdivision of Rancho Del Paso" filed in the office of the Recorder of Sacramento County, State of California, March 4, 1911, in Book A of Surveys, Map No. 94; thence in a northerly direction along the center line of Watt Avenue to the point of intersection of the center lines of Watt Avenue and Marconi Avenue; thence in a westerly direction along the center line of Marconi Avenue to the point of intersection of the center lines of Marconi Avenue and Bell Avenue; thence in a southerly direction along the center line of Bell Avenue to the point of intersection of the center lines of Bell Avenue and Cottage Way; thence in an easterly direction along the center line of Cottage Way to the point of intersection of the center lines of Cottage Way and Fulton Avenue; thence in a southerly direction along the center line of Fulton Avenue to the point of intersection of the center lines of Fulton Avenue and Arden Way; thence in an easterly direction along the center line of Arden Way to the point of beginning.
